

# FACILITATING THE GIVING CYCLE THROUGH LIFELONG DONATIONS

# Learn, explore, grow, and give back, always.

That's the simple, yet powerful message we believe donors Arthur (Art) and Phyllis DuBois would give to today's younger generations, especially those in their hometowns of Coudersport and Waverly. It's also exactly how the couple spent their very full lives together.

A native of Coudersport, Art worked at IBM for many years where he met his loving wife, Phyllis. Their dedication to donating, specifically through Community Foundation for the Twin Tiers, was measured in decades. Even now, after they've passed, their gifts continue funding the future for local organizations and students in Potter County.

"Art and Phyllis gave to a number of charitable organizations, but often did so anonymously," said Pat Larsen, friend and legal counsel to the DuBois family. "Today, many of the charities that are benefiting from their most recent donation are ones they had previously established funds for as anonymous donors."

Their latest gift holds the record for the largest donation in CFTT history. The \$3,131,996 donation continues the DuBois' lifetime support of the Potter County Historical Society, Eulalia Cemetery Association, Hearts Response (The Christmas House), Teacher's Pet Rescue, Coudersport Fire Department, Coudersport Ambulance Association, and the Austin Fire Department.

The DuBois' connections to these organizations ran deep. Art spent 55 years of his life serving as a volunteer firefighter at the Coudersport Volunteer Fire Department. Beyond his own direct connections, Art's family history is rooted in the Coudersport area. His family had ties with the historical society, formerly a library, and his family members are buried together in the Eulalia Cemetery.

Beyond the generational connections to the area, Art and Phyllis had an affinity for helping underprivileged members of the community through The Christmas House, which operates out of their home church.

"Art and Phyllis were world travelers who performed critical work for a large corporation," said Larsen. "However, they always stayed true to their roots and never lost appreciation for what they considered one of life's most precious gifts - education."

Through their generous donation, Art and Phyllis established scholarship funds at their respected high school alma maters. The Wright Family Scholarship will support graduating seniors from Waverly High School with a gift of \$313,000. Additionally, the DuBois Family Scholarship Fund was established with a gift of \$940,000 for graduating seniors from the Coudersport Area High School, with a preference for studies in science, technology, engineering, or mathematics.

Both scholarships highlight the DuBois' strong appreciation for education. The funds will open the doors for others to further their education and careers, a dream the DuBois family prepared for through their well-planned donations.

"From the scholarships established by Art and Phyllis DuBois, I know their hope would be for people to take advantage of the educational opportunities given to them," Larsen said. "With those opportunities, they would want them to further themselves, learn from those experiences, and then hopefully one day find themselves in a position where they too can give back to the community."

# **Types of Funds**

**Community Foundation for the Twin Tiers directs 18** funds that have been established by individuals, families, nonprofits, businesses, and Community Foundation itself for charitable purposes.

#### **Competitive Community Grant Funds**

Increase the impact of your gift, and put it to work solving our community's most pressing problems, not just alleviating symptoms. Competitive grant applications are carefully vetted by our Grants Committee, and, after thorough due diligence, grants are awarded based upon community need, impact, and organizational capacity. Gifts may be designated to specifically support certain areas, such as animals, arts & culture, human services, education, conservation & environment, civic engagement, or recreation.

#### **Community Impact Funds**

Community Impact Funds have been established for each county in our five county areas. These funds may be added to and will meet the most pressing issues in that county.

#### **Donor Advised Funds**

Donor advised funds offer the advantages of a private foundation, yet have greater tax benefits. They are especially useful for donors who make a charitable deduction one year and make distributions from income or principal in future years. Donors are able to participate actively in the giving process by recommending organizations to receive grants.

#### **Field Of Interest Funds**

Field of interest funds allow a donor to invest in specific causes. These funds can support a broad array of interests such as the arts, education, or health. The donor specifies his or her interest at the time the fund is created and may rely on Community Foundation to identify organizations capable of making the greatest impact.

#### **Designated Funds**

Make your gift today

Designated funds ensure long-term support for a specific nonprofit organization identified by the donor at the time the fund is established. The named organization receives an annual disbursement from the designated fund.

#### **Organization Funds**

Nonprofit organizations may place their endowed funds at Community Foundation, thus assuring their donors that funds earmarked for the future will be invested wisely and used appropriately. Community Foundation manages the funds as part of its investment portfolio and distributes payments.

#### Scholarship Funds

Community Foundation's scholarship funds bring together students in need and individuals who care about postsecondary education to enable more students to reach their educational goals. Scholarship funds may be established to benefit a specific student.

# **Fund Structures**

After identifying the appropriate fund type to achieve your goals, a fund structure is subsequently selected to align with the anticipated size, activity level and life span of your fund. The fund structure determines the applicable administrative fees and how the fund's assets are invested.

#### Spend Down

Cash

With a Spend Down fund, gift principal is wholly available for granting. Spend Down funds can be thought of as charitable checking accounts, where there is regular, ongoing grant activity.

#### Endowment

Endowment funds provide stable, perennial financial support. An endowment operates similarly to a private foundation, yielding a set percentage for granting each year while eliminating administrative duties. You may recommend grant recipients or pass your charitable legacy to your children. Investment income accrues to the fund, and a guarterly administrative fee based on a percentage of assets supports the Foundation's operations.

#### **Blended Option**

Blended option funds offer fund holders the ability to participate in the investment returns of the Foundation's portfolio. These funds may function like a Spend Down fund or an endowment fund, depending on the needs of the fund holder, but are not formally endowed. Investment income accrues to the fund, and a quarterly administrative fee based on a percentage of assets supports the Foundation's operations.

There are two ways to get a grant from the Community Foundation:

#### **Donor-Recommended Grants:**

The Community Foundation stewards a variety of donor advised funds. Grants are awarded from a donor advised fund based upon recommendations from the donors who set up the fund or their designated representatives.

#### **Competitive Grants:**

The Community Foundation has several funds that award grants on a competitive basis. Each competitive grant fund has a unique focus area, like youth or strengthening vulnerable families. Each fund also has different application requirements.


